Information We Collect

We may collect the following types of information from users:

Financial Data: Blockchain transaction information (e.g., wallet activity) that is publicly available on the Bitcoin blockchain but does not identify you personally unless combined with other information.

We process your data for the following purposes:

Legal Basis for Processing

We process your personal data based on:

- Your consent, where required (e.g., for marketing communications).
- Our legitimate interests in improving the Site and protocol functionality.
- Legal obligations where applicable.

Use of Cookies and Similar Technologies

What Are Cookies?

Cookies are small text files stored on your device when you visit a website. These help us improve your browsing experience by remembering preferences, enabling core functionalities, and collecting analytics.

Why We Use Cookies

We use cookies to:

- Enhance Functionality: Enable Site features such as user logins.
- Analyse Performance: Track usage to improve content and design.

Right to Restrict Processing

You can request us to limit processing under certain conditions, such as verifying the accuracy of data.

Right to Object

You can object to processing based on legitimate interests or direct marketing.

Right to Data Portability

You can request your data in a structured, machine-readable format to transfer it elsewhere.

Right to Withdraw Consent

Where processing is based on consent, you can withdraw it at any time without affecting the lawfulness of prior processing.

Right to Lodge a Complaint

You have the right to lodge a complaint with a supervisory authority if you believe your data rights have been violated.

We implement technical and organisational measures to protect your personal data against unauthorised access, loss, or misuse. However, no transmission over the Internet can be guaranteed as 100% secure.

Data Retention

We retain your personal data only for as long as necessary to fulfill the purposes outlined in this policy or as required by law.

International Data Transfers

As a global protocol, your data may be processed or stored outside your country of residence. We ensure appropriate safeguards for such transfers in compliance with data protection laws.
